Minimum Advertising Price Policy

Revised September 2010

REID RACING, Inc. has adopted a unilateral Minimum Advertised Pricing (MAP) policy for all *REID RACING* branded products. *REID RACING* transmission and off-road equipment are premium brand products with a reputation for performance and quality. *REID RACING* has invested significant resources in product development and marketing to build and maintain this reputation and generate goodwill toward the *REID RACING* brand. *REID RACING* has adopted this policy to prevent price-based advertising that tends to cheapen or degrade the image of *REID RACING* products in the marketplace, and thus erode its goodwill and brand reputation.

All *REID RACING* distributors are required to comply with this policy. *REID RACING* trademarks and intellectual property may only be used as specified in this policy, and only by *REID RACING* Authorized Distributors. *REID RACING* intellectual property includes the *REID RACING* name, trademarks, logos, images, part numbers, descriptions, advertising copy, drawings, specifications, test results, instructions, vehicle application data, and any other marketing information developed and published by *REID RACING*.

Under this unilateral MAP policy, any consumer or public advertisement of *REID RACING* branded products must not result in a net price that is below the MAP price. *REID RACING* has established a MAP price (which is the LIST PRICE) for each part number. These prices are published by part number via pricing data notifications and are available to direct customers as well as authorized distributors. Net price is defined as the price less the value of any advertised discounts offered by *REID RACING*. Free shipping or installation may be included at the MAP price.

This policy applies to all forms of public or consumer advertising including but not limited to television, radio, print advertising, catalogs, letters, coupons, internet advertising, email solicitations, websites, or online auctions. Advertisements must not indicate that a price lower than MAP is available. It is a violation of this policy if the lowest price displayed to the consumer is shown with a strikethrough or obliteration, or with text indicating that a lower price is available. Internet advertisements or auctions that do not show an actual un-obliterated price must not allow the consumer to click to see the price unless the price shown is at or above MAP price. If the consumer must add the item to a shopping cart to see the advertised price, then the price shown must be at or above MAP price.

In the event that *REID RACING* determines that a distributor has violated this policy, then *REID RACING* will attempt to send a notice of policy violation to the distributor. If the distributor does not take appropriate action to remove the offending material within a period of time defined by *REID RACING*, then *REID RACING* will suspend the distributor and notify the distributor that the distributor is not permitted to purchase *REID RACING* products, until further notice from *REID RACING*. It is the responsibility of each distributor to monitor *REID RACING* price changes and review all advertisements before publication to ensure compliance with this policy.

REID RACING Authorized Distributors are required to promote the use of *REID RACING* products, effectively respond to requests from customers, represent *REID RACING* products in a positive and professional manner, advertise responsibly, use *REID RACING* intellectual property only as authorized, and comply with all *REID RACING* policies. *REID RACING* reserves the right to revoke Authorized Distributor status from a reseller, or discontinue selling *REID RACING* products to any distributor or reseller, for any reason that we determine to be in the best interest of our company.
